Gestation and Lactation: Transition to 50% Swine 16% Active Mini Pig and 50% Swine 18% Youth Mini Pig. For higher energy requirements, as in the case of large litter size or multiple breeding's, increase Swine 18% Youth Mini Pig to 60% of the daily intake.
